 - 1) They had to clean out the Saw #5 Twice
 - 2) Reason for this is a screen that was placed in the vacuum system to catch \$18.00 nuts that will, at times fall down into the system.
 - a) Dado blade use causes larger chips to catch in the screen , and this will clog up the vacuum system
 - 3) Maintenance strongly suggests that when using the Dado Blade
 - a) Clean and vacuum saw well, and be sure it is not plugged up
 - b) Open the bottom doors, and vacuum this out!
- D) Powermatic Lathe
 - 1) Looking for the correct parts
